REGULAR MEETING JUNE 30, 2020

	A regular meeting of the Board of Stewards of Fairhope United Methodist Church was held on June 30, 2020, on the Zoom app. Gene Lammers opened the meeting with a devotional at 6:00 PM.

MINUTES	The minutes of the June 9, 2020 meeting were approved online prior to this meeting.
NOMINATIONS	Darren McClellan reported that the Committee had found people to fill three remaining leadership positions. Linda James will serve as Secretary of the Board, Chuck Huguley will serve on the SPR Committee, and Brune Stewart will serve on the Trustees. Gene Lammers asked if there were any objections to approving the new nominations by acclamation and, hearing none, deemed the nominations approved.
FINANCE	Jeff White reported on the May financial statements. So far this year giving is \$73,000 below budget, but expenses are \$120,000

	below budget. With the \$200,000 the church received from the Payroll Protection Program, we are in a good cash position. There is some concern about giving from non-pledged givers, which is down in the March to May period by \$94,000 compared to the same period last year.
REOPENING READINESS	Chuck Huguley reviewed the three-phase plan for reopening the church that his team has developed. A copy of the plan is on file with these minutes. He stressed that the plan is fluid and the dates will have to adjust to changing circumstances. Gene Lammers spoke about how rapidly the Covid statistics have worsened. Darren McClellan discussed what other churches in the area are experiencing, and said that the metric he planned to use in moving forward with reopening was for the Covid numbers to be stable or declining for two weeks. There was a discussion of the plan among the Board members. Chuck asked the Board to approve the framework laid out in the plan, with the timing to be determined in response to the Covid situation. In response to a question, Gene clarified that the motion was to approve the framework, and to authorize Darren's team and the Reopening Team to implement the plan and decide on the timing of each step. The motion passed by a clear majority of raised hands.
PASTORS' REPORTS	Laura Parker spoke briefly about the status of small-group meetings at the church. Darren expressed his desire for some sort of send-off for graduating Seniors, and invited input on how he could best communicate the status of the reopening plans to the larger congregation.
ADJOURNMENT	After a closing prayer from Emily Garner, the meeting was adjourned at 7:10 PM.
